Jamee Miller summarized. Provided an update and expressed appreciation to the Trustees for sponsoring their 2024 "E Ho'owaiwai Ē" event, which was attended by over 400 people and exceeded fundraising goals. The organization, founded in 2020, has transitioned from being volunteer-run to hiring staff and expanding direct programming. Recent initiatives align with OHA's strategic priorities in health outcomes and economic stability, including training Native Hawaiians returning to the community as peer support specialists, supporting family visitation and healing days for incarcerated individuals' families, and developing the next generation of Native Hawaiian leaders to reduce intergenerational incarceration. The speaker introduced 'Ōpio participants to share their experiences.

'Ōpio from Hawai'i Island summarized. Reported on their work with the World Indigenous Peoples' Conference on Education (WIPCE), including planning youth conferences, organizing a youth community space, and participating in other international events. They attended the Indigenous Health and Wellbeing Conference in Australia, where they discussed ending intergenerational incarceration and the importance of cultural connection. They contributed to a resolution passed in the last legislative session and testified on a bill to eliminate youth fees and fines; while the bill did not pass, the resolution promoted culturally based service, such as working in loko i'a or lo'i. They are also active in the Konaola leadership program, conducting community issue research, data collection, and public outreach.

Jamee Miller summarized. Efforts to end intergenerational incarceration and plans to expand the 'Ōpio program by recruiting youth from O'ahu, Hawai'i Island, and Moloka'i, where a local leader has expressed interest in coordinating. The sensitive nature of the issue, explaining that openly discussing it fosters healing. The organization has been active in presentations and outreach, often requested to speak, and has partnered with the Gerbode Foundation. Most funding is received from philanthropic sources outside Hawai'i due to challenges in securing local grants. A recent collaboration produced the "Ho'iwai" report on Native Hawaiian incarceration, which is being used to encourage investment in Hawai'i. In October, approximately 25 philanthropists will visit to explore partnerships and leverage funding alongside OHA's support.

Germaine Meyers summarized. Expressed concern over recent budget changes affecting Hawaiian charter schools, particularly Ka Waihona (600 students) and Kamaile (900 students) on the Wai'anae Coast, each receiving \$100,000 less than originally proposed in May. The funding reduction was equal to that of a school serving 35 students and questioned the fairness of distribution without considering enrollment size. They stated that local leaders and principals were not made aware of the changes before being asked to support the budget. The speaker criticized the process as rushed, lacking transparency, and limiting the ability of strategic and implementation staff to present their budgets to the Board. They urged that such budget decisions be brought back to the community for input.

Chair Kaiali'i Kahele Announced a strategic shift in advocating for the protection of Mauna Kea, noting that after years of litigation and the recent loss of National Science Foundation funding for the Thirty Meter Telescope, efforts will now focus on a stewardship model led by Native Hawaiians and informed by community voices, in collaboration with Governor Josh Green and the Mauna Kea Stewardship Authority. The decision was described as a recommitment to Mauna Kea through unity, cultural integrity, and focused advocacy, honoring the responsibility to mālama the mountain with purpose and respect.

Chair Kaiali'i Kahele The Board of Trustees will travel to Kaua'i to join Trustee Dan Ahuna for community site visits, community meetings, and a Board meeting. Similar visits have been held on Maui and Moloka'i and are considered vital for the Board and administration to connect with beneficiaries and inspire follow-up action. The Chair announced that the next Hawai'i Island site visit for the O'ahu satellite office will take place in Waimea, Kamuela, on Thursday, July 3, 2025, inviting all beneficiaries and community members to participate. Positive feedback has been received on the satellite offices, recognizing staff and BSA contributions. The Chair also thanked beneficiaries and community members for their understanding of recent adjustments to meeting schedules and agendas due to the new Sunshine Law signed by Governor Josh Green and updated OIP guidance on posting agendas and materials. The Board is committed to complying with the requirement to post materials three full business days in advance while maintaining proactive discussions.
