Germaine Meyers summarized At the BOT meeting on July 25, 2025, Chair Kahele raised concerns during the discussion on the proposal to appoint Elena Farden and Hailama Farden as Co-Interim Chief Operating Officers for 30 days with compensation consistent with other interim appointments. Chair Kahele stated his objection was based on the fact that the proposed appointees are a married couple, noting that this could present internal and external concerns, including optics, best practices, and potential perceptions of conflict of interest.

It was noted that Hawaii Revised Statutes §378-2 prohibits discrimination in employment based on marital status, which is a protected characteristic under Hawaii's Employment Practices Act. Examples of marital status discrimination include denial of promotions, unequal pay, or adverse employment actions. Hawaii courts have previously ruled that "no-spouse policies," where employers take adverse action against employees because of their spouse's employment, constitute marital status discrimination. Concerns were expressed that Chair Kahele's remarks regarding the Fardens' marital status in relation to their eligibility for interim appointment may be inconsistent with these legal protections.
