Trustee Akina Thank you, I am going to vote no. I want to express my heartfelt unity with you in wanting to bring about a workplace environment at OHA that has high morale where people are present and where we are available to serve all beneficiaries. I am with you on that, and I understand that is your motivation behind this action. The reason I caution us and ask that we vote no on it is because of several factors having to do with best practice in an organization. Our roles as Trustees should be governance, not management. Governance means ultimately setting policy. The action we are about to take would be to intervene in administrative policy and in a

rapid way. In light of the retirement of our current CEO, our focus should be on a search for a CEO and the ensurance that we will not be micromanaging. Specific concerns of mine are those expressed by our Administration. Concerns are that we may hurt recruitment efforts especially by changing the dynamic of recruitment in the post-Covid world and we all know that we are down in terms of our number of workers. Finally, I am concerned about the people factor and timing. This measure to end all telework practice takes place immediately within the month of June so that it's done by July 1st. I don't know what kind of impact that will have on our own people and whether it will affect their life and morale; More than that, I encourage us in finding the right CEO to move us forward and maintaining the difference of governance as we practice our roles as Trustees. Thank you so much.

Chair Hulu Lindsey Aloha kākou everyone and welcome to our Board of Trustees meeting, this meeting can be viewed and observed via livestream at www.oha.org/livestream. We are recording today's meeting for the sole purpose of producing written minutes.

Joining us today is our Board Secretary-Lehua Itokazu, my two Aides-Kanani Iaea and Amber Kalua, and our Chief of Staff-Colin Kippen. We also have Judge Robert Klein-our Board Counsel and our CEO-Sylvia Hussey. Sylvia, will you introduce our staff that are with us today.

Sylvia Hussey, CEO Good Morning Trustees, with us today is our COO-Casey Brown, CFO-Ramona Hinck, Interim General Counsel-Everett Ohta, Interim Sr. Legal Counsel-Nietzsche Ozawa, Human Resouce Director-Kai Mana Peres-David. We are also supported by IT with Arlene and Dan.

New Business

Chair Hulu Lindsey Before we move to our first item on the agenda, do we have anyone signed up to speak on this item II.1.

Board Secretary Yes, we have Germaine Meyers.

Germaine Meyers Aloha Chair Hulu, Vice Chair Mililani Trask, Trustees, staff and beneficiaries, my name is Germaine Meyers, I am an OHA beneficiary for beneficiary advocacy and empowerment. I am also a Nānākuli beneficiary lessee. I understand from today's agenda and packet that yesterday's RM Committee meeting on grant recommendations from Administration are on today's agenda for ratification. Since the RM Committee no longer includes community concerns, I'm forced to address my concerns about what I heard from Administration during the meeting in response to trustee questions about the grant recommendations and processes. In addition, several times the Administration never provided a direct response to the questions, but instead we read the packet information without giving a clarifying answer. Ka Pouhana recently told me that OHA uses three to four outside grant evaluators per category. Yesterday's packet clarified that applicants will

be recommended for an award if their score is 80 points. In regard to the 'Ahahui grants, I feel the applications were scored differently than the other categories. There were only two grant evaluators that reviewed 'Ahahui compared to three evaluators for the other categories. In addition, Administration never provided the scores of the two 'Ahahui applicants that were disapproved as they did with the other categories. Trustees, when you go into the community who serve the lahui and they ask you why their application for OHA grants were disapproved or continuously disapproved, how can you confidently answer them? The grant process and recommendations are not transparent, but vague. There were flow charts and lots of words in the packet yesterday regarding grants, but relevant and sufficient information were absent and null. Some of the other applicants in other categories were denied approval because they were scored by three evaluators. Had they been scored by two evaluators, the same as 'Ahahui, their applications would have met the scoring criteria since two of their three scores were over 80 points. If the education grants were scored by two evaluators like 'Ahahui instead of three, the applicant, Hana Arts, would have been recommended for approval of the \$100,000 grant request. Hana Arts scores were 80 through 85. Two of their scores meet the 80 point threshold, instead only Purple Mai'a Foundation was recommended to receive a \$200K grant with the scores of 93, 95, and 75. How can two evaluators come to a conclusion of 82 and 85 but one evaluator gave a 56? No explanations were provided by Administration for this huge discrepancy. If Administration provided sufficient information to Trustees about each applicant received through all processes, then Trustees could be confident that the small pool of nonprofits that serve the lahui in our State were treated fairly. Also, they could be provided with how they could improve and be approved for future grants. When these details are provided, you can make recommendations for grants. I recently completed a State GIA grant application, all completed applications are posted for public review. In addition, applicants must provide details of how much grant money they have received in the past from the State but also from the City and Federal government. I know the packet from Administration didn't include the applicants that previously received grants from OHA and how much money they received from other government entities. Mahalo.

Germaine Meyers In regards to today's proposed agenda item the Interim CEO, I am confident that Colin Kippen has the historical experience and expertise with working with the lāhui and OHA Trustees. I have seen him in the community doing this work. In addition, he understands what is currently needed with Administration from being present at OHA during the pandemic and now after the pandemic. Thank you Chair.

Chair Hulu Lindsey I will call on the Vice Chair to make the motion.

Trustee Trask I am going to move that the Board move to approve this; however, I would like to have some changes moving to appoint Colin Kippen to be our current Interim CEO effective July 1st. I want to add language to make it clear. Trustees, take a look at the action item, the last paragraph, it says if and when we approve this, the Board will consult with our Board Counsel and create the empolyment memorandum so we will be taking action first but we know we will have a follow up on it. This is where I want to make my comment. The Board, following our vote on this which I know we will appove, the Board will then meet with Board Counsel to create the employment memorandum and I want to make clear that when we consider the Interim CEO salary, terms, and rights, we ensure the Interim CEO, effective from July 1st, will be paid the salary at the same rate as our current CEO stepping out. To be clear, when we vote on this, we will be proceeding with the Interim contract, we know from KUMABE we will have three to four months. He will be serving under the same contractual agreement, I do not want a problem that someone comes in as an Interim and is not compensated fairly. Is there any questions on it?

Chair Hulu Lindsey Thank you Trustees, may I introduce to you our new Interim CEO effective July 1, 2023, Colin Kippen. You have a unanimous vote, do you wish to say anything to the Board?

Colin Kippen Aloha, thank for this opportunity. As I've been thinking about this for the last several days, I started thinking what it would be like if I was a physician. There was a couple of things that physicians think; the first thing is do no harm, and that is where we need to be as we move through a transition. The second thing is treatment without a diagnosis is malpractice. As I think about the position that I will be in, those are two important concepts as we move through this transition with new leadership. We are human beings, we like the beaten path, some people like concrete paths as we go into the future. What I am thinking is that we are on different paths but as we find those paths and we figure out what those paths are going to be, those two things that I cited are going to be my guiding stars. I want to stabilize. I want to help this Board, this staff, and the community to make this transition as smooth as possible. Aloha.

Community Concerns and Celebrations

Germaine Meyers For the record, my name is Germaine Meyers and I am an OHA beneficiary for beneficiary advocacy and empowerment. Mahalo nui for the opportunity to share my community concerns. Trustees, during yesterday's RM Committee meeting, I heard Administration speaking about a non-agenda item. Ka Pouhana shared that she is working on a recommendation for a new category for an out-of-state grant in addition to other recommendations she would like Trustees to take into consideration. When this item was discussed in the past, concerns were raised about grant money being reduced for in-state beneficiaries. In-state beneficiaries suffer with the high cost of living in Hawai'i. Out-of-state has better housing opportunities and lower cost of living. Again, Administration speaking about a non-agenda item was a violation of Sunshine Law. Also during yesterday's meeting, I heard Trustees Brickwood and Souza bring up a non-agenda item when they spoke about Kaka'ako Makai deliverables. I do not recall seeing it on the agenda yet full discussions took place absent lāhui input. Trustee Brickwood discussed and recommendations for a site visit were made by Administration. Many of the lāhui have seen the non-deliverables from past Administrations including the DTL masterplan that I participated in but also the current deliverables from the current Board. Again, speaking on a non-agenda item is a violation of the Sunshine Law. Ke Akua pu, god bless all of you.

Trustee Galuteria One of the achievements of the Board is that Governor Green invited us to be a part of the cabinet meeting and we did attend one. Will you share with the Board what that was like?

Chair Hulu Lindsey I will write a memo to the Board, it is not agendized.

Trustee Trask I just have some comments before we end this meeting. I hope beneficiary Germaine Meyers is still on. I am very concerned with what she showed us today. What germaine pointed out to us is that we do not have a uniform standardized review process. I want to make this comment that I will be following up with her but if there is any Trustee that sees the same problem please let me know.

Trustee Souza, this is not directed to anyone but in the future if we do agendize something especially the budget that has to do deal with a particular area we can engage in full and free discussion. There is no violation and we are all aware of Sunshine Law. I just want that on the record.

Chair Hulu Lindsey Yes, correct, we did discuss the budget yesterday. Anyother questions or concerns?

II. Issue

III. Background and Discussion

In accordance with HRS, CHAPTER 92, PUBLIC AGENCY MEETINGS AND RECORDS §92-2.5 Permitted interactions of members: (b) Two or more members of a board, but less than the number of members which would constitute a quorum for the board, may be assigned to: (1) Investigate a matter relating to the official business of their board; provided that: (A) The scope of the investigation and the scope of each member's authority are defined at a meeting of the board; (B) All resulting findings and recommendations are presented to the board at a meeting of the board; and (C) Deliberation and decision making on the matter investigated, if any, occurs only at a duly noticed meeting of the board held subsequent to the meeting at which the findings and recommendations of the investigation were presented to the board.

Term/Duration. The term of the Permitted Interaction Group expires at the completion of the assigned tasks or at the discretion of the Chair of the Board of Trustees, subject to later adjustment, but in no event later than November 30, 2023.
