Chair Hulu Lindsey Makes an announcement that the Board needs to move into Executive Session due to proprietary information. She also inquires if there are any testimonies regarding the items that will be discussed in executive session.

Germaine Meyers Aloha, my name is Germaine Meyers, and I am an OHA beneficiary of Advocacy and empowerment. I am also a Nānākuli Hawaiian Homestead lessee. Mahalo to the Administration for acknowledging the State Auditor Report 23-04 which was released last year in March 2023. I feel that before we entertain a new strategy or a new consultant, we need to take into consideration what the State Auditor highlighted. The State Auditor Report shared concerns that OHA Trustees, all nine of you, are not fulfilling your fiduciary duties regarding Kaka'ako and all the lands owned by OHA. According to findings one, without a real estate strategy or land acquisition policies, OHA's approach to identifying and acquiring commercial properties is AdHoc, raising questions about the prudence of Trustee action. Who's

kuleana is it to create these policies? According to OHA's website, it explains the duties of each Committee. It says the Committee on Resource Management (RM) recommends policies for the management of the agencies investment portfolio and other fiscal and budgetary matters. It also develops policies and guidelines for OHA's land acquisitions, dispositions, development and management. I was very surprised to see in the audit report that it said it was outdated as far as, no policies are present regarding land acquisition, development and management of OHA's lands. It says in 2014, OHA acknowledged that it needed these guidelines and policies. So, who was in charge of the RM Committee since 2014? We know that in the last four years it was Chair Waihe'e and Vice Chair Luana Alapa. Prior to that it was Dan Ahuna and Bob Lindsey. If I go back to 2014 when it was acknowledged, it was RM Chair Colette Machado and Vice Chair Haunani Apoliona. This is where the ball has been dropped as far as policies. The Trustees are not recognizing the kuleana when they are Chair and Vice Chair of committees. That is one concern that I have. When is the RM Committee going to agendize for these policies to be developed? Since the report has come out in March, I am looking for the minutes after the audit report was posted in March. Has the RM been working on the policies in the Committee? The audit report also highlighted the in audible in the acquisition, the land next to Nā Lama Kukui. It states that the CEO and the manager at the time, who is now at DHHL, submitted a bid, \$45 million or \$47 million. Trustee Lee, who was Vice Chair at the time, stated when he was running in 2022 that he had something to do with that purchase but that was done outside of knowledge of the Board as far as putting in the bid. I think there should be an audit. We just had all these audits. What happened to Trustee Akina and Grassroots Institute checking on watchdog agencies and OHA? How can you let one Trustee from OHA and these managers of OHA put in these bids without knowledge of the Board? I also want to bring up the tent, I was concerned about that and all the wasted money because of non-due diligence and because of non-policies that would have guided the due diligence. I see my time is up but what I am trying to say is that the RM Committee needs to get on it with the policies before you take any transfers of land and before you continue with Kaka'ako. Ke akua pū.

Faith Chase Aloha Kakahiaka, I am Faith Chase, I am the Director of Fundraising and Strategic cCommunications for Re-use Hawai'i. I just wanted to remind this body and others that Re-use Hawai'i is non-profit and Hawai'i's only licensed deconstruction service provider. We have several programs such as a tree milling program and redistribution program. We have had a budding growth with the work force development program during COVID. We are now up to 41 employees and 30% of our staffers are from that workforce program. We were just awarded from the Congressional Representative Schatz for \$500,000. We also submitted a Letter of Intent for an EPA grant. We are moving forward and identified Chaminade as our *in audible* and we have eight community-based organizations. We are excited about that and it is a \$20 million dollar grant. This will help promote green jobs. I just wanted to remind this body that we are doing good work.

Quinn Aloha, I just want to express gratitude for hosting us at lot L. We have 4,000 people who visit us every month. We are an incredible source for low-cost building material and we also do work force development. It is our eighth year as an organization, we have forty-seven employees. We've had amazing support from the State, County, and local foundations. Trustee Galuteria helped us with our very first GIA back in 2017. I just want to list our impact; last year we diverted about 500 tons of material from the landfill. As you know, there is a waste crisis and landfill issues for all of Hawai'i. The landfills are closing in 2028, and the City and County are charged with finding a new landfill. Our programs are proactive and a staple to address that issue. We save people a ton of money by what we offer. We track our greenhouse gas emission, last year we prevented 300,000 tons of house gas from entering the atmosphere. 1/3 of our staff who work for us come from various partnerships. Thank you for helping us make an impact. The last piece I want to talk about is the lease renewal process. We started a couple years ago with

CBRE, and I know you switched to Colliers. In November, we got an offer for a five-year lease. We were waiting to hear back with some details regarding yard space and followed up a bunch of times and we never heard back. We didn't hear back from Colliers until last month. We were shocked that they mentioned that they want us to vacate. It really caught us off guard. We are here to ask for your help. We feel like we could be partners with OHA and help fulfill some of your objectives and continue to be a community resource. As the next steps, we would love to work out a way to continue to be in Hakuone. Thank you for your time.

Germaine Meyers Aloha, I am Germaine Meyers. As I stated earlier, I understand that it is a wonderful opportunity to get lands transferred, but I do want to highlight that we need these land policies. I am assuming if these policies existed, then they would be in the packet. If they do exist, I would like to get a copy of it. What has become a common theme on the Board with some new Trustees, and sometimes the incumbent Trustees, are "pet projects". We have a fifteen-year strategic plan. Before we start taking land, we need to understand that we have a foundation of policies, bylaws, and procedures that are also being followed. What I am trying to express is that I am concerned that Trustees come in with the "pet project" mentality; I want to have casinos, or I want to acquire the land around Nā Lama Kukui. The RM Committee needs to come and do their kuleana and do these policies. Why aren't these things getting done? You need to be here for the lāhui and not your personal projects. I want to acknowledge that I went to broken promises, Gene Ward, on Prince Kūhiō day, March 26th at the State Capitol, when the discussion came about on why we are not unified. Governor Waihe'e stated that we need to unify. We need the leadership to unify. I think you as our leaders, you need to be pono before you expect the lāhui to be pono.

Chair Hulu Lindsey Moving on to the next item on the agenda with Hailama Farden

G. FESTPAC and Kamehameha Day Lei Draping Updates – Hailama Farden, Sr. Director of HawaiianCultural Affairs

Hailama Farden, Sr. Director of Hawaiian Cultural Affairs Mahalo for allowing me some time to share about these upcoming events. Most of these events are published on the website. The official dates for FESTPAC will be June 6-16th. June 6th will be the opening ceremonies with the festival village opening on the 7th. I am aware that they are planning a trip to Mauna 'Ala to pay respects to our ali'i. My recommendation for these events at this moment is the Trustees to be participating fully or partially in the ceremony. That is part of the contract that was scheduled with OHA for the \$1.5 million, there will be seats available for our Trustees. You will see a conflict with King Kamehameha celebrations within the period.

The lole and attire, it is my recommendation to this Board that the lei hulu that you received in your installation as Trustees will be the unifying regalia for the Trustees of the Office of Hawaiian Affairs. Some of you have more than one so you can determine which one is appropriate for you to wear. We are recommending a cultural protocol workshop, regarding when we wear a lei, the respect given and protocol that comes with it. Example: you wouldn't put a floral lei on top of your lei hulu. Also, I think it may be important to have some training on what is FESTPAC and who are the twenty-eight countries affiliated.

Finally, ho'okupu. I have been able to pull ideas from friends to put together some recommendations. Mahalo to Trustee Ahuna because Anuhea was able to guide us to a place where we could get these bowls, 'umeke. This gift will be from the Office of Hawaiian Affairs to the delegation. The items in this 'umeke are very significant. Pa'akai, 'uo, alaea, kapa, all contexts will be given to share about the contents.

Trustee Ahuna Do we have everything we need for these 'umeke? Would water be something?

Hailama Farden, Sr. Director of Hawaiian Cultural Affairs Yes, you do. Not only is it sustainable, but lā'au in many ways too. We could think of a way to capture the wai within the vessel itself. We also talked about offering a basket with mea'ai in it too.

I will move on to the lei draping. Honolulu lei draping is on June 7, 2024, 1-5 pm. I have received a commitment from Trustee Galuteria. Other Trustees may want to be there also. Kohala has a lei draping ceremony on June 11, 22024 at 8 am. Washington DC is on June 16, 2024, at 2:00 pm in the Emancipation Hall. Investment Purpose

- Hakuone is part of the Investment Lands portion of OHA's portfolio.
- The primary purpose for owning Investment Lands is to earn a minimum 5% real rate of return (e.g., 5% plus inflation) and meet or exceeds industry benchmark returns.
- A secondary objective is creating a piko in urban Honolulu that will be a gathering place for Native Hawaiians, including dedicating a portion of the site for a significant programmatic element such as a cultural center.



OHA's Ownership History

A Settlement Agreement executed by the State and OHA in February 2012 resolved past claims to ceded land revenues from November 7, 1978 to June 30, 2012. Key settlement terms are summarized below.

- 1. The Hakuone lands (approximately 30.7 acres) were transferred to OHA as-is.
- 2. OHA assumed ownership subject to all existing leases and other encumbrances.
- 3. The parties mutually agreed that the lands were worth \$200 million at the time of the settlement.
- 4. These values were validated by independent appraisals for the State and OHA.
- 5. When transferred in 2012, residential uses were prohibited on the makai side of Ala Moana Boulevard.

OHA's Ownership History

- OHA has undertaken several efforts to jump start development on its land holdings, including the following planning initiatives.
 - ✓ The November 2013 effort led by Group 70, Rider Levett Bucknal ("RBL") and Sanford Murata Inc.
 - ✓ The Kuhikuhi Pu'uone Collaborative (WCIT et al) planning effort undertaken in 2014-15.
 - ✓ Kuilei effort undertaken in 2022 to 2023.
- To date, over \$10.0MM has been spent on various planning efforts.
- A lot of good work has been performed over the years, including extensive community outreach, feasibility analysis, issue identification, infrastructure planning, etc. However, OHA has not been able to sustain any of these beyond basic planning and report generation, and most of these reports are now dated.

OHA's Ownership History

- An appraisal in December 2022 estimated the market value for the 30.7 acres to \$43.6MM assuming a bulk sale to one buyer. This value reflects the revetment repair costs but excludes any cost for environmental remediation.
- For the 12-month period ending June 30, 2024, the Net Income for Hakuone was \$2.485MM. Similar figures for 2023 and 2022 are \$1.493MM and \$1.429MM respectively.
- OHA's investment has not achieved intended objectives.
 - ✓ The FY2023-24 cash on cash return was only 1.2% when using the original property value of \$200MM ($$2.485MM \div $200.0MM$)
 - ✓ Assuming the December 2022 appraisal is accurate, the investment value has declined by 78%.

 - ✓ Over the 12 year period of ownership, Hakuone has not achieved a 5% real rate of return.
 ✓ Had OHA invested \$200MM in the NHTF and earned an 8% rate of return, the invested assets would be worth over \$500MM today.

OHA's Challenges with Hakuone

Why is it so difficult for OHA to advance the Hakuone development program?

- No consensus vision
- No consensus on how to proceed (e.g., sale, joint venture, ground lease, other)
- Limited staff and lack of internal skills to put together an executable plan
- No full-time focus because of other organizational priorities
- Failure to maintain consultant continuity to advance the project
- Governance pushes too many decisions to the BOT
- OHA's focus has been getting the zoning OHA wants rather than working with the zoning in place
- \$15 to \$20 million needed for studies and predevelopment activity to optimize parcel pricing, not including G&A.
- OHA is a political body, not a development/investment entity
- Development community is skeptical of OHA's ability to execute on a vision

What is an LLC

- An LLC is a limited liability company.
- It is a common business structure used by almost all real estate investors and operating companies.
- The LLC structure limits the amount of financial risk for an owner.
- The owner of an LLC can be a person or another legal entity (e.g., a corporation or partnership).
- An LLC can be single-member or multi-member.
- Owners exercise control over the LLC through an Operating Agreement.
- There is frequently a managing member who makes day-to-day decisions.
- Major decisions, however, are typically reserved for all the Members through the Operating Agreement.



Hakuone Execution Options

- 1. Status Quo Conduct land planning and make limited horizontal improvements (e.g., infrastructure) without modifying the current OHA decision making structure.
- 2. Bulk Sale Exit the investment by welling the lands to a development entity other than those portions OHA wishes to retain for cultural/programming purposes.
- 3. Master Joint Venture Select a development partner who will master plan the property and make limited horizontal improvements to optimize land pricing from future sales, joint ventures or ground leases.
- 4. Master Ground Lease Ground lease all 30.7 acres to a development entity who will master plan the property and execute on a development program.
- 5. LLC Conduct land planning and make limited horizontal improvements (e.g., infrastructure) within a separate LLC with separate staff and governance.

Execution Option - Status Quo

High Risk/Low Return

Pros	Cons
 Does not require a separate legal structure. Fewer stakeholder concerns. Greater stakeholder transparency. 	 Nothing is being modified to improve future outcomes. Execution Option - Master Ground Lease

Low Risk/Low Return

Pros Cons

- Limited development risk to OHA under a ground lease structure.
- OHA will limit its capital outlays as master ground lessee will be responsible for most planning and development costs.
- OHA does not need to internally staff for development.
- Secure and stable income stream once the master ground lease converts to individual ground leases for each development parcel.

- Master ground leases are incredibly complicated to negotiate. Staff will require assistance of sophisticated external advisors throughout the process.
- Many developers will not build under a ground lease structure, which could affect quality of the Lessee.
- Ground leasing will generate the lowest returns to OHA but also has the lowest risk.
- There will be limited BOT control over activities of development except those that can be reasonably negotiated as part of a ground lease.
- Counterparty risk if the wrong Master Ground Lessee is selected.

Execution Option - Single Purpose LLC

Medium to High Risk/Medium to High Return

Pros Cons

- Provides indirect OHA control while ceding dayto-day decision making to properly experienced professionals, which mitigates risks to OHA.
- Staffing limitations are resolved by aligning staff compensation with the market.
- A Board with real estate expertise can bring needed oversight to the development program.
- OHA can select the Board members for the new entity whom OHA's BOT trusts.
- Liability can be contained within the LLC.
- Redirects significant organizational resources (time and money) to more mission related outcomes and lets the separate entity harvest value from Hakuone.
- Overcomes the challenges of developing within OHA structure.
- Policies and procedures specific to development are not needed at the OHA level.

- No obvious capital funding plan outside of a sale of one parcel or capital infusion by OHA.
- Cash flow of \$2.0MM per year will likely be reinvested in site-specific planning near term rather than made available for mission-related spending.
- Higher overhead costs will reduce near term cash flow.
- Does not eliminate development risk to OHA.
- Income may be subject to taxation.
- Legislative approval may be required for the LLC transfer.
- New entity is separate from OHA control and may periodically make decisions that are at odds with BOT changing priorities.
- Stakeholder concerns with LLC structure.

Director of Hawaiian Ethos

- The Director of Hawaiian Ethos is responsible for institutionalizing and upholding the ethos* of the Office of Hawaiian Affairs (OHA). This role involves planning, coordinating, directing, supervising, and participating in all aspects of OHA's programs and activities to promote, support, and advocate for Hawaiian protocol, culture, history, arts and language within and on behalf of the organization.
- The Director of Hawaiian Ethos works in concert with the Sr. Director of Hawaiian Cultural Affairs to oversee cultural projects, which may include cross-collaboration with several of OHA's partners and programs, identifies the types of programs that need to be developed to benefit the Hawaiian community, establishes cultural goals for Advocacy Initiatives, and coordinates Division activities with Executive Assistants.
- This position works closely with the Senior Director of Hawaiian Cultural Affairs, the Hawaiian Cultural Operations specialist and one day hopefully the OHA Archivist, Historian & Hawaiian Cultural Research.
- *Cultural ethos refers to the shared beliefs, attitudes, and values that define a culture or society, and influence its practices and customs

Hawaiian Cultural Operations Consultant

- Reports to the Director of Hawaiian Ethos
- is responsible for assisting the Director of Hawaiian Ethos and Senior Director of Hawaiian Cultural Affairs in managing and executing cultural initiatives, projects, and programs within the Office of Hawaiian Affairs. This role functions similarly to that of a Project Manager, providing strategic support to align with OHA's mission and the Mana i Maoli Ola (OHA's 15-year Strategic Plan).
- The Hawaiian Cultural Operations Consultant will be responsible for creating and assessing OHA's Hawaiian cultural scope, strategies, and priorities to identify opportunities and challenges, and plan for organizational growth. The candidate will manage organizational change to align and execute initiatives that support and align with Mana i Maoli Ola. Additionally, the Consultant will build and foster a high-performing organizational culture and cross-functional teams immersed in Hawaiian culture.
