Ka Pouhana Hussey: Good afternoon Trustees, I will call on our Public Policy Manager Jocelyn Doane to come up, we also have our Chief Advocate Keola Lindsey here.

Public Policy Manager Doane: Aloha, so we are not going to have that really long of a meeting until next week because we have the Executive Session item today. We thought we would just give a quick update on the package. All our bills were introduced; we are in the process of reviewing them to determine if any substantive changes have been made.

In fact, for OHA-5 there were substantive changes made, assumedly accidentally by the drafting department at the legislature. So, when we submit our testimony, we will be requesting that changes be made back to reflect the bills that OHA had originally approved. Certain words in the bills would make substantive differences and I don't think it was intentional, so we'll be doing that.

There were also substantial changes made to the organization of OHA-3. Our first review of the changes makes us think they're not substantive, but we're going to continue to look at them if they get a hearing to request amendments, if necessary. We're in the process of getting committee assignments. All the Senate ones were done already, so we've gotten them – but this wasn't updated before we printed this out because we wanted to make sure you received it in a timely manner. That's our update as it stands now. Thank you.
