
Funding



2. Public Land Trust Revenues The Public Land Trust (PLT) is a subset of state lands which is held in trust for the betterment of the conditions of Native Hawaiians, and the general public. PLT lands are comprised of former Crown and Government lands of the Hawaiian Kingdom. Hawai'i's constitution establishes OHA in part to receive and administer Native Hawaiians' pro rata share of revenues derived from the PLT. The pro rata share is generally understood to be 20% of the revenues from PLT lands. How this 20% should be calculated is a matter of longstanding debate between OHA and the State.

In 2006, the State of Hawai'i agreed to pay OHA a fixed \$15.1 million per year as a temporary approximation of the PLT share. At 41% of OHA core operating budget, this is the second largest source of funding.






Beneficiary & Community Investments

As noted above, OHA's first spending priority for FY22-FY23 is to increase OHA Beneficiary and Community Investments to support Native Hawaiian 'ohana and communities. In the FY21-FY22 biennium budget, OHA allocates \$30.3 million over the biennium budget to various beneficiary and community investments, which constitutes 41% of the core operating budget. Of this budget: \$6.0 million allocated to OHA's long-term commitments to DHHL revenue bond debt service for housing infrastructure (20%).

\$13.6 million is allocated to grants aligned with implementing the new Mama i Mauli Ola Strategic Plan Framework (45%); \$6.0 million to Hawaiian Focused Charter Schools (HFCS) (20%); \$1.7 million is to an Emergency Financial Assistance (EFA) Program (5%); \$1.0 million to Higher Education Scholarships (3%); \$1 million to the Kūlia grants (3%); \$822 thousand to Community Sponsorships (1%); \$400 thousand to Ahahui Events (1%); and \$265 thousand to Disaster Aid (1%).

SETTING CONTEXT¹

Figure 1. Housing Stability Scale below indicates what we know about Native Hawaiians compared to non-Hawaiians on the housing stability scale; and what we need in terms of supply of housing and occupancy readiness for Native Hawaiian families. This grant solicitation is focused on impacting Native Hawaiian households in the Overcrowded and Doubled – Up stability scale by assisting with occupancy readiness.




Figure 1. – Housing Stability Scale

Quality Housing Grants Purpose: Strengthened Capability for 'Ohana to Meet Living Needs, Including Housing; Strengthened Effective Implementation of the Hawaiian Homes Commission Act

Leveraging partnerships to ensure Native Hawaiians can obtain affordable rentals as well as homeownership while also engaging in opportunities to affect legislation that support Hawaiian Home Lands, overall housing costs, and housing supply that will greatly enhance the ability for Native Hawaiians who desire to remain in Hawai'i.

Housing

Grant considerations include community-based programming that address "occupancy ready" housing needs for our Native Hawaiian community and meet at least one of the following strategic directions and one associated outcome: the number of Native Hawaiians that can secure and retain stable rental housing; the number of Native Hawaiians that can obtain homeownership; affordable non-traditional housing options; and housing unit supply on Department of Hawaiian Home Land trust lands.

"Occupancy ready" housing is defined as ready-to-move-in housing that can be used anytime by the buyer or renter, when the required payment(s) is(are)made, related mortgage/rental documents are completed, and a move in date has been established within the initial two year grant term.

Applicable licenses and/or permits required for the proposed project must be secured when the applicant is notified by the Grants Program that the application will be recommended for award. If an applicant is unable to provide the required licenses/permits, the Grants Program will not recommend the applicant to the Board of Trustees for award and notate the existing status (e.g., pending licenses and/or permits).

Educational Pathways Grants Purpose: Strengthened and Integrated Community, Culture based Learning Systems

Supporting initiatives, leveraging partnerships, engaging in strategies to develop educational pathways that strengthen culture-based education, early education, K-12 and post-secondary education will ensure that Native Hawaiians are grounded in their past while participating in a technologically oriented future.

Education Grants include considerations for culture and community-based programming that utilize 'ōlelo and nohona Hawai'i to meet educational needs of families and communities.

Grants also include considerations for awards to support individuals in postsecondary pursuits, with a priority on increasing Native Hawaiian teachers and administrators in kaiapuni, Hawaiian-focused charter schools, and any other setting in which Hawaiian is the medium of instruction; and gap areas of post-secondary supports (e.g. career, technical, internships, fellowships, work-study).

Economic Stability Grants Purpose: Strengthened capability for 'ohana to meet living needs, including housing; strengthened effective implementation of the Hawaiian Homes Commission Act

Engaging in strategies to enhance the economic development and financial empowerment of the lāhui will ensure that Native Hawaiians progress toward a state of economic stability.

Economic Stability Grant considerations include culture and community-based programs and practices to strengthen 'ohana abilities to pursue multiple pathways toward economic stability and meet at least one of the associated outcomes: increase 'ohana capacity to provide keiki and kupuna care; increase access to capital and credit for community strengthening Native Hawaiian (NH) businesses and individuals; strengthen resource stability (e.g. financial, subsistence, other); and/or increase NH employment rate.

May also include programs that increase the number of successful, community strengthening Native-Hawaiian owned businesses; establish new markets for Native Hawaiian products (kalo, loko i'a grown fish, etc.) that can provide Native Hawaiian producers a livable wage; and/or establish and operationalize an indigenous economic system consistent with Native Hawaiian knowledge, culture, values and practices.
