#### A BILL FOR AN ACT

RELATING TO HAWAIIAN EXPERTISE IN LAND USE AND RESOURCE MANAGEMENT.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. In Act 169, Session Laws of Hawaii 2015, the
- 2 legislature found that pursuant to Hawaii's constitution,
- 3 statutes, and case law, the State recognizes a mandate to
- 4 protect Native Hawaiian traditional and customary rights.
- 5 Accordingly, Act 169 amended chapter 10, Hawaii Revised
- 6 Statutes, to require the office of Hawaiian affairs to
- 7 establish, design, and administer a training course on Hawaiian
- 8 rights, the sources of these rights, and how the infringement of
- 9 these rights affects the Hawaiian people, and further required
- 10 new members of certain state councils, boards, and commissions
- 11 to complete the training course within one year of their
- 12 appointment.
- 13 Unfortunately, despite the regular provision of notice to
- 14 board and commission administrators, a significant number of
- 15 board and commission members subject to the mandatory training
- 16 course continue to fail to comply with their training course



- 1 completion responsibility. As a result, critical land use and
- 2 resource management decision-making may continue to be less than
- 3 fully informed on Native Hawaiian concepts, practices, and
- 4 rights.
- 5 The legislature further finds that, in recognition of the
- 6 importance of incorporating Native Hawaiian knowledge, values,
- 7 and rights in resource management decision-making, certain
- 8 critical decision-making bodies, such as the land use commission
- 9 and board of land and natural resources, are statutorily
- 10 required to have at least one member with experience or
- 11 expertise in Native Hawaiian practices or resource managment
- 12 approaches. However, requiring just one member of the land use
- 13 commission and one member of the board of land and natural
- 14 resources to possess this experience or expertise has not
- 15 resulted in decisions that consistently recognize or incorporate
- 16 Native Hawaiian knowledge, values, and rights.
- 17 These issues in turn have led and continue to lead to
- 18 substantial conflict, distrust in government decisions and
- 19 processes, and even legal action against the State, and may
- 20 further foreclose critical opportunities to ensure our islands'

- 1 resiliency and self-sufficiency through culturally-informed land
- 2 use and resource management.
- 3 Accordingly, the legislature intends to ensure a deeper
- 4 understanding among board and commission members of the State's
- 5 legal responsibilities to Native Hawaiians, Hawaii's political
- 6 history, the public land trust, Native Hawaiian traditional and
- 7 customary rights, Hawaii's water laws and the public trust
- 8 doctrine, and laws relating to Native Hawaiian burials. The
- 9 legislature further intends to ensure greater recognition and
- 10 incorporation of Hawaiian knowledge, values, and rights in land
- 11 use and resource management decision-making.
- The purpose of this Act is to:
- 13 (1) Prohibit council, board, and commission members who
- fail to meet their training course completion
- requirement from serving on a permitted interaction
- group or voting on matters before their respective
- 17 councils, boards, or commissions;
- 18 (2) Require council, board, and commission members who
- fail to meet their training course completion
- 20 requirement to complete their training requirement or
- 21 be reconfirmed by the senate by the end of the regular

I		legislative session following their training course
2		completion deadline;
3	(3)	Require the office of Hawaiian affairs and the
4		department of land and natural resources to compile an
5		annual report of council, board, and commission
6		members who have failed to complete their training
7		course requirement, and to submit the report to the
8		governor and legislature no later than twenty days
9		prior to the convening of the regular legislative
10		session;
11	(4)	Require four members of the board of land and natural
12		resources to be nominated from a list provided to the
13		governor by the office of Hawaiian affairs; and
14	(5)	Require four members of the land use commission to be
15		nominated from a list provided to the governor by the
16		office of Hawaiian affairs.
17	SECT	ION 2. Section 10-42, Hawaii Revised Statutes, is
18	amended t	o read as follows:
19	"[+]	§10-42[] Training relating to native Hawaiian and
20	Hawaiian	traditional and customary rights, natural resources and
21	access ri	ghts, and the public trust. (a) All council, board,

1	and Commit	ssion members identified in section 10-41(a) shall
2	complete	the training course administered by the office of
3	Hawaiian	affairs pursuant to this section within twelve months
4	of the da	te of the member's initial appointment. Members who
5	fail to c	omplete the training course within the required period
6	shall be:	
7	(1)	Prohibited from serving on a permitted interaction
8		group or voting on a matter before their respective
9		council, board, or commission until the mandatory
10		training course is completed; and
11	(2)	Removed from their respective council, board, or
12		commission at the end of the regular legislative
13		session following their deadline to complete the
14		training course, provided that members shall not be
15		removed if they complete the mandatory training course
16		or obtain the advice and consent of the senate to
17		continue serving on their respective council, board,
18		or commission by the end of the regular legislative
19		session following their deadline to complete the
20		training course.

1	(b) Individual votes taken by council, board, and
2	commission members who failed to complete the mandatory training
3	course may be challenged and subject to being nullified and
4	voided following a contested case proceeding.
5	(c) The office of Hawaiian affairs and the department of
6	land and natural resources shall prepare an annual report of all
7	council, board, and commission members who have failed to meet
8	the training requirement in this section as of September 21 of
9	each year, which shall be made available for public inspection
10	at the office of Hawaiian affairs and the department of land and
11	natural resources, and submitted to the governor and the
12	legislature no later than twenty days prior to the convening of
13	each regular session of the legislature.
14	$[\frac{(b)}{(b)}]$ (d) The office of Hawaiian affairs, at its own
15	expense, shall establish, design, and administer a training
16	course relating to native Hawaiian and Hawaiian traditional and
17	customary rights, native Hawaiian and Hawaiian natural resource
18	protection and access rights, and the public trust, including
19	the State's trust responsibility. The training course shall
20	include:

1	(1) Historical information, explanations, and discussions
2	of key state laws, state constitutional provisions,
3	and court rulings that reaffirm and provide for the
4	protection of native Hawaiian and Hawaiian rights; and
5	(2) A discussion of the importance of public trust
6	resources and various programs to native Hawaiian and
7	Hawaiian rights.
8	$[\frac{(c)}{(c)}]$ (e) The office of Hawaiian affairs, at its own
9	expense, shall develop the methods and prepare any materials
10	necessary to implement the training course, administer the
11	training course, and notify each council, board, and commission
12	identified in section 10-41(a) that attendance in a training
13	course is mandatory.
14	$[\frac{d}{d}]$ The office of Hawaiian affairs shall offer the
15	training course at least twice per year.
16	$[\frac{(e)}{(g)}]$ The governor shall provide to the office of
17	Hawaiian affairs the names of persons required to take the
18	training course pursuant to this part within thirty calendar
19	days of their initial appointment [by the governor]."
20	SECTION 3. Section 26-15, Hawaii Revised Statutes, is
21	amended to read as follows:

"$26-15 Department of land and natural resources. (a)

    The department of land and natural resources shall be headed by
3
    an executive board to be known as the board of land and natural
4
    resources, except for matters relating to the state water code
5
    where the commission on water resource management shall have
    exclusive jurisdiction and final authority.

         The board shall consist of seven members, one from each
8
    land district and three at large. The appointment, tenure, and
9
    removal of the members and the filling of vacancies on the board
10
    shall be as provided in section 26-34. At least one member of
11
    the board shall have a background in conservation and natural
12
    resources, as provided in section 171-4. At least one member,
13
    other than the member with a background in conservation and
14
    natural resources, shall have demonstrated expertise in native
15
    Hawaiian traditional and customary practices, as provided in
16
    section 171-4, and at least four members shall have been
17
    appointed from a list of nominees submitted to the governor by
18
    the office of Hawaiian affairs, as provided under subsection

    (b), to ensure assistance to the board to better administer the
    public lands and resources with respect to native Hawaiian

3	The governor shall appoint the chairperson of the board
4	from among the members thereof.
5	The board may delegate to the chairperson such duties,
6	powers, and authority, or so much thereof, as may be lawful or
7	proper for the performance of the functions vested in the board.
8	The chairperson of the board shall serve in a full-time
9	capacity. The chairperson, in that capacity, shall perform
10	those duties, and exercise those powers and authority, or so
11	much thereof, as may be delegated by the board.
12	(b) Lists from the office of Hawaiian affairs to fill
13	vacancies on the board shall be submitted as follows:
14	(1) For a vacancy attributable to the expiration of a
15	term, the list shall be submitted on the first
16	business day of December prior to the expiration of
17	the term; and
18	(2) For a vacancy that occurs during a board member's
19	term, the list shall be submitted within thirty
20	business days after the vacancy occurs.

1 [<del>(b)</del>] (c) The department shall manage and administer the 2 public lands of the State and minerals thereon and all water and coastal areas of the State except the commercial harbor areas of 3 the State, including the soil conservation function, the forests 4 and forest reserves, aquatic life, wildlife resources, state 5 6 parks, including historic sites, and all activities thereon and 7 therein including, but not limited to, boating, ocean recreation, and coastal areas programs. 8 9  $[\frac{(c)}{c}]$  (d) The functions and authority heretofore exercised 10 by the commissioner and board of public lands (including the 11 hydrography division and the bureau of conveyances), the Hawaii water authority, the commission on ground water resources, the 12 13 Hawaii land development authority, the soil conservation 14 committee, and the commission on historical sites and the function of managing the state parks and the function of 15 promoting the conservation, development and utilization of 16 forests, including the regulatory powers over the forest 17 reserve, aquatic life and wildlife resources of the State 18 heretofore exercised by the board of commissioners of 19 20 agriculture and forestry as heretofore constituted are

1	transferred to the department of land and natural resources
2	established by this chapter."
3	SECTION 4. Section 205-1, Hawaii Revised Statutes, is
4	amended by amending subsection (a) to read as follows:
5	"[ $\{-\}$ ] (a)[ $\{-\}$ ] There shall be a state land use commission,
6	hereinafter called the commission. The commission shall consist
7	of nine members who shall hold no other public office and shall
8	be appointed in the manner and serve for the term set forth in
9	section 26-34. One member shall be appointed from each of the
10	counties and the remainder shall be appointed at large; provided
11	that one member shall have substantial experience or expertise
12	in traditional Hawaiian land usage and knowledge of cultural
13	land practices[-], and at least four members shall have been
14	appointed from a list of nominees submitted to the governor by
15	the office of Hawaiian affairs. Lists from the office of
16	Hawaiian affairs to fill vacancies on the board shall be
17	submitted as follows:
18	(1) For a vacancy attributable to the expiration of a
19	term, the list shall be submitted on the first
20	business day of December prior to the expiration of
21	the term; and



1	(2) For a vacancy that occurs during a board member's
2	term, the list shall be submitted within thirty
3	business days after the vacancy occurs.
4	The commission shall elect its chairperson from one of its
5	members. The members shall receive no compensation for their
6	services on the commission, but shall be reimbursed for actual
7	expenses incurred in the performance of their duties. Six
8	affirmative votes shall be necessary for any boundary
9	amendment."
10	SECTION 5. Notwithstanding the amendments made by this Act
11	to section 26-15, Hawaii Revised Statutes, each current sitting
12	board member may serve the remainder of the member's term, and
13	until the expiration of the current terms of all current sitting
14	board members, the decisions and other actions of the board
15	shall not be subject to challenge on the basis that the
16	requirement of section 26-15, Hawaii Revised Statutes, that four
17	members of the board be appointed from lists submitted by the
18	office of Hawaiian affairs, has not been met.
19	SECTION 6. Notwithstanding the amendments made by this Act
20	to section 205-1, Hawaii Revised Statutes, each current sitting
21	commission member may serve the remainder of the member's term,



- 1 and until the expiration of the current terms of all current
- 2 sitting commission members, the decisions and other actions of
- 3 the commission shall not be subject to challenge on the basis
- 4 that the requirement of section 205-1, Hawaii Revised Statutes,
- 5 that four members of the commission be appointed from lists
- 6 submitted by the office of Hawaiian affairs, has not been met.
- 7 SECTION 7. Statutory material to be repealed is bracketed
- 8 and stricken. New statutory material is underscored.
- 9 SECTION 8. This Act shall take effect upon its approval.

#### Report Title:

Office of Hawaiian Affairs (OHA) Package; Department of Land and Natural Resources; BLNR; State Land Use Commission; Council; Board; Commission; Members; Training; Appointment

#### Description:

Prohibits council, board, and commission members from serving if the member has not completed, within the requisite time, the required training course related to native Hawaiian and Hawaiian traditional and customary rights, native Hawaiian and Hawaiian natural resource protection and access rights, and the public trust, including the State's trust responsibility. Requires that at least 4 members of each the board of land and natural resources and the state land use commission be appointed from a list submitted by the office of Hawaiian affairs.
