6. Explain in detail, why it is not practicable or not advantageous for the department to procure by competitive means:

In an effort to ease the transition of a large number of staff to the office, OHA Administration reviewed the transportation and parking issues for the staff. As the owner of Na Lama Kukui, OHA waived the parking charge for NLK-based staff for July 1, 2023 to December 31, 2023. With a large number of staff returning to the office, there were not enough stalls available at NLK to accommodate all staff in need of parking. It would not be practicable nor advantageous for the OHA to procure by competitive means since the additional parking stalls would need to be within close walking distance to NLK to ensure the health and safety of our staff.

7. Explain in detail, the process that will be or was utilized in selecting the vendor/contractor/service provider:

The OHA Operations staff reached out to all neighboring vendors to inquire about renting parking stalls. The only vendor with available parking stalls for rent was Castle & Cook Properties, Inc. at their Dole Cannery garage location. All other vendors contacted within close walking distance of NLK did not have stalls available for rent.
