POLITICO Pro is an online Federal and State database which provides customized and current political, legislative, and regulatory news and tracking dating back 10 years, thorough Federal and State policy analysis, Federal and State directories, and legislative and reulatory compasses.

6. Describe in detail the following:

a. The unique features, characteristics, or capabilities of the goods, service or construction.

POLITICO Pro offers exclusive reporting and briefings on timely legislative issues. Through its unique sources, POLITICO is able to provide legislative text before it is posted on public websites like congress.gov, althought it also pulls information and data from those sources as well. POLITICO Pro offers subscribers the ability to set up customized email notifications by subject matter and user, so different users know about events as they occur and do not have to go through materials that do not pertain to their specific work. It offers legislative tracking dating back 10 years, and the ability to compare legislative drafts. POLITICO Pro also offers up to date contact, work history, job descriptions, and some biographical information for staff and officials throughout Congress and the federal administration.

b. How the unique features, characteristics or capabilities of the goods, service or construction are essential for the department

Part of the Washington DC Bureau's (WDCB's) responsibilities is to track all proposed federal legislation and regulations to analyze any impacts on Native Hawaiians and weigh in where appropriate. POLITICO Pro's tools allow us to stay as up to date as possible, as well as to monitor the thousands of bills, proposed rules, and notices moving through Congress and the U.S Government for impacts. WDCB is also responsible for advocating to the federal government on behlaf of Native Hawaiians. POLITICO Pro's constantly updated directories of Congressional and Federal agency staff and officials allows us to make sure that we have the most current contact information and know more about the staff we interact with through their bios and work histories on POLITICO Pro. Finally, POLTICO Pro's system of email alerts allows us to stay on top of any new developments that could affect our work.

7. Describe the efforts and results in determining that this is the only vendor/contractor/service provider who can provide the goods, services or construction.

WDCB staff reviewed POLITICO Pro's website and tools to determine whether POLITCO Pro would meet our office's needs for monitoring, analysis, and staff directory services. POLITICO's website identified three major competitors as being CQ Roll Call (Fiscal Note), Bloomberg, and Congress.gov. WDCB staff also searched the internet for other competitors, which included both other premium subscroiption providers as well as open public sources provided by the federal government. We then reviewed the offereings from the competitor's sites to determine if any of those services would be a reasonable subsitute for the services POLITICO offers. We found that they do not.

8. Alternate source. Describe the other possible sources for the goods, services, or construction that were investigated but did not meet the department's needs.

Congress.gov - Does not provide news, has very limited analysis capabilities, and no staff directories; Bloomberg - Does not provide legislative tracking; and CQ Roll Call (Fiscal Note) - Does not provide Federal legislative tracking for 10 years prior and it seemed like several products that would be needed to cover POLITICO Pro's suite of services, which lacked the same integration and customization tools.

6. Feature: The good, service, or construction has the following unique features, characteristics, or capabilities: POLITICO Pro offers exclusive reporting and briefings on timely legislative issues. Reporting covers a broad range of issues that focus on specific and niche issue areas. Through its unique sources, POLITICO is able to provide legislative text before it is posted on public websites like congress.gov, although it also pulls information and data from those sources as well. POLITICO Pro offers subscribers the ability to set up email notifications by subject matter, so users know about events, legislation, and regulations as they occur. POLITICO Pro notifications are sent to subscribers based on personal and organizational preferences, and provide updates on bills as they occur. Additionally, it provides draft legislation made available through various sources, including individual Committees. It offers legislative tracking dating back 10 years, and the ability to compare legislative drafts between Congresses. This level of tracking is not possible to achieve on Congress.gov. POLITICO Pro also offers up to date contact, work history, job descriptions, and some biographical information for staff and officials throughout Congress and the federal administration.

7. Essential Features: The good, service or construction has the following unique features, characteristics or capabilities to accomplish the work:

POLITICO Pro offers federal legislative tracking software dating back 10 years, which is not available on any other platform.

8. Alternate source. The following other possible sources for the good, service, or construction were investigated but did not meet our needs because:

Congress.gov - Does not provide news, has very limited analysis capabilities, and no staff directories. Additionally, it does not allow for effective tracking because it must be done manually, which limits the number of bills we can track based on time resource limitations. CQ/Roll Call - Does not provide Federal legislative tracking 10 years prior; Bloomberg - Does not provide legislative tracking.
