III. COMMUNITY CONCERNS

Chair Colette Machado States for the record that there are two individuals who have signed up. Before I call Keli'i Makekau to the microphone I wanted to acknowledge our beneficiary Germaine Meyer, all Trustees were sent a packet of information. She will be our next speaker. She calls Keli'i Makekau to the table.

Mr. Keli'i Makekau States that he would he like to comment around two points. In the past I been in and asked about the status of Kaka'ako Makai. I have not been at the committee I've been watching it livestream. Eat the Street is not at the site any more. I see that property is not generating any more funds. In the past my comments were centered around the water rights issue. When we got the properties we didn't get the water rights. In the past the only one who addressed me was former Trustee Apoliona and she said the water rights were something they would revisit after we got a master plan. That was four years ago and haven't heard anything. You know that would strengthen our portfolio and the land situation there and make our property more attractive. Is there ever going to be or is it negated and we just going with what we got.

My second point is that I saw the discussion on HCR94 the one that disappoints me most about the resolution in general is sort of the two-prong attack. What it insinuates is that the Trustee position needs to be qualified in order to do their job basically calling you folks incompetent lame ducks with name popularity. Whereas someone with a skilled back ground can execute this job more. Obviously that principle is going be heavily debated I know tomorrow they are going to release a judgement on it at the capital. My only thing was that one element was missing, and elected office you have a privilege of serving as you all know. As you guys run, there is a certain honor and distinction as being a public servant. In froth in doing so the office itself gains a certain amount of respect has a little bit of admiration from the community but there is a certain decency to it. The part that seems to be missing is the most simplest aspect of it when you fall under scrutiny whether it be from the public or your personal actions draw you in the lime light there needs to be an accounting in yourself and this. Many people have criticized you folks as to not being the people's ear and there have been back and forth discussions and power struggles as we've seen in doing so. The one topic that has never come up has been resignation. That is the utmost respect as we saw with Louis Kealoha as when he came up and what not he was finally left with no other option. But out of decency and respect for the office in which he served as not to affect the constitution. I hope if there is a report or whatever is generated and asked by OHA that at least it be considered and echoed. Because that is the greatest respect for yourself and for the office. If you are indeed complacent or found to be guilty of that you would consider such an action or at least echo it. Because that's what it entails.

Lastly the burden always falls upon the voter populace, we vote you folks in and that is a part of our democracy. That is the only trademark that I have not seen and echoed in this thing. We start off every meetings in prayers, we hold our self to the most dearest Hawaiian sincerest values but I never see it echoed in the execution of the stations you all hold and what not. Instead I always see more infighting and ingress and accusations or what not. Sometimes it better to go backwards in this case to this then let decency and honor come forward.

Chair Colette Machado Calls on Trustee Hulu Lindsey to update you when we will be having an update on Kaka'ako.

Trustee Carmen Hulu Lindsey States that in two weeks we will have our consultants here picking up where we left off about a year and a half ago. I don't think we will ever get the ocean side of our properties but the move is to move forward with whatever approval we have on the property today. That is what we will be discussing in two weeks.

Mr. Makekau Thanks Trustee Hulu Lindsey.

Trustee Carmen Hulu Lindsey Mentions that we will also be taking action on an EIS.

Chair Colette Machado Calls Germaine Meyers to the table.

Ms. Germaine Meyers Introduces herself to the Board, she is a beneficiary and a lessee of Nanakuli Hawaiian Homestead.

(Ms. Meyers reads her written testimony which is attached)

Chair Colette Machado Asks if there are any questions.

Trustee Carmen Hulu Lindsey Clarifies that she met with SPIRE the day before, she asked if there was anything that we should prepare to give out to the Trustees or if he had anything or if he was going to cover anything that we had in our possession. The fact he brought up that 95 page report surprised us. He just caught us off guard. We did not prepare it on purpose, we were not informed that he was going to present it. He gave me and outline and told me this was the outline he was going to present. I asked if we were giving anything out to the Trustees. Actually that is what happened, I don't want my staff to be criticized I just wanted to make that clarification.

Chair Colette Machado States that though we didn't get it in advance it just made us pay better attention. It's just the beneficiaries that might be felt slighted there were not updated properly. But within the time frame of the meeting we all received copies plus extra. She asks if Germaine got a copy?

Ms. Meyer Confirms that she did not, and mentions that some of the nuha came from the president from the previous organization. But I have to say yesterday I was very impressed by their presentation. I don't have all the details you folks have but from the slides I saw it was really interesting and something to look more into.

IV. UNFINISHED BUSINESS

A. CEO's 15-Minutes Update on Ho'oulu Lāhui Aloha and OHA Activities

Chair Colette Machado Calls on Lisa Victor.

Ms. Lisa Victor Offers the following announcements. We want to mahalo our Native Hawaiian Revolving Loan Fund Board of Directors, First Foundation Bank and staff for approving our first Hua Kanu business loan of a \$150,000. On Tuesday we finalized the transaction with Reliant Trucking owned and operated by Mr. Bernard Kea. We are scheduled on Friday to sign another Hua Kanu Loan with Goldwing Supply Service. Our loan products are intended to help level the playing field for Native Hawaiian entrepreneurs with the overall

goal of increasing economic self-sustainability for our community. We want to thank the Board of Directors and our staff for that.

(Trustee Peter Apo arrives to the meeting at 10:27 am)

Trustee Leina'ala Ahu Isa Asks what are the two businesses.

Ms. Lisa Victor States that they are Reliant Trucking, Inc. and the other is Goldwing Supply Service Inc. Both Native Hawaiian owned businesses.

Then next item is cyber security awareness. I want to Mahalo our team, I thank Chair for supporting our cyber security awareness. I want to let you know that the firewall has been configured. As of this morning we have identified 7,137 individual attacks on our systems. We have successfully defended against them. Rest assured our firewall is capable and protecting the organizations assets. In the next month you will see a bunch of things and recommendations we will bring forward to protect the work that OHA does and make sure it happens.

Trustee Keli'i Akina Asks about the instances of the cyber breeches, if there were systematic or just random.

Ms. Lisa Victor Clarifies that the 7,137 attacks on our system were noted as top five system attacks that are trying to invade us the first one being a net bios query. Those are the thing that our firewall is capable of getting to that detail to identify them and mediate them.

Trustee Keli'i Akina Asks if we were targeted?

Ms. Lisa Victor States that it was just general browsing, that you have all of these things floating around trying to find their way in anywhere it can. For the last month we worked really hard to make sure that we tightened that. We are getting reports every day now to understand our vulnerabilities to the network.

I wanted to let the board know that our Biennium Budget period is open to the community and I brought some hard copies for our beneficiaries or whomever wants some. We have posted to OHA.org, our social media, since we have opened up our comment period we have 6800 visits and we have four people sharing the post. We are hoping that people take the time to make some comments like Germaine has and we are ready to respond to them.

I have a couple more good news from Washington Bureau regarding our recently established Native Hawaiian Congressional Fellowship program. Next step in OHA's native Hawaiian Public service pipeline initiative. The past two years we worked to putting together a congressional fellowship placing recently college graduates in full paid 9 month fellowships at the Hawaiian Congressional Delegation Offices in Washington DC. This is a partnership with Kamehameha Schools. So we are proud to say that through that partnership we are able to launch the program this past fall.

Last but certainly not least we would like to ask the Board of Trustees along with the staff to acknowledge Gwen Valbuena for 35 years of Service. She is the longest tenured employee of OHA you are significantly contributed to the office's success you have been leader, truly dependable and a historian everything OHA. Mahalo you Gwen and thank you for making service to Native Hawaiians your priority.

Chair Colette Machado Gwen started at OHA in 1982 and wanted to point out that she grew up in Waialua, she graduated from Waialua high school. She has three children, one son, two daughters and is the primary caregiver to her parents and has six grandchildren.

Ms. Gwen Valbuena Thanks the board and those present.

Trustee Leina'ala Ahu Isa Asks about the situation at Kakaako.

Ms. Lisa Victor States that currently that is in litigation.

Chair Colette Machado States that we will need to discuss in Executive Session and when Trustee Carmen Hulu Lindsey feels it would be appropriate time to bring the matter to the committee.
